# WELCOME

# DRESS CODE

Dress code at practice and competition is very important. We are in the public eye often, and as such must maintain "classy" attitudes and attire. Please follow the rules and remember to both look and act like a Capital City Gymnast at all times.

At PRACTICE, all athletes are to wear practice attire that is close fitting and not a cropped or midriff style. Leotards are best. Spandex shorts or leggings are optional. Jewelry (other than stud earrings) is not permitted. Fitness watches are also in this category.

At COMPETITION, when not competing, athletes need to wear their Capital City Gymnastics uniforms, warm ups, or gym colors and tennis shoes. No sandals, slippers or boots.

PARENTS AT COMPETITION are encouraged to wear Capital City Gymnastics parent gear or team colors to competitions. Our athletes love the support that they see in the stands when parents are decked out in red and navy! Parent gear will be available to order prior to our first competition. Please note, only parent gear purchased through our team stores is permitted. Please do not use our name or logo on any other apparel or other products.

<sup>\*</sup> All meets are billed accordingly for each level. There is no discount or deduction of meet fees if athletes do not attend a meet.

<sup>\*\*</sup>Meet weekends usually run Friday-Sunday with the final schedule and which levels compete when not available until a few weeks before each meet.

<sup>\*\*\*</sup>Participation in a regionals event requires a minimum all around score of 36. Entries and coaches travel are not included in the comp. account and will be billed upon qualification.

## FINANCIAL COMMITMENT

There are two types of financial commitments required of competitive team gymnastics families. The first is the monthly training fee that is due on the first of each month and covers all team practices, instruction and team gatherings. The second is the competition account (comp. account) that consists of every expense associated with participating on a travelling competitive gymnastics team. Each team's expenses vary and are due in installments prior to the beginning of the competitive season. These installments are due on the 15th of each month

\*\*Monthly tuition is due on the first of each month. A \$25 late fee will be charged on all accounts with outstanding balances on the 10th of each month. Please see Autowithdrawal Form for auto-draft of monthly tuition and/or comp. account installments.\*\*

#### **Team Budget and Expenses**

Each family also has a competition account, or "comp. account" with HAC that the family is responsible for according to the due dates outlined in the installment schedule. The table below shows the costs that are associated with a competitive team gymnastics. Although it is a substantial expense for the season there are many individual fundraising opportunities through the HAC. Participation in fundraising events are at your discretion only and the portion of the funds raised by your family during each event goes directly to your competition account. Monies fundraised above and beyond the comp. account fees can be applied to the monthly tuition for team members. Often, there are families who completely pay off their accounts prior to the start of the season through the summer raffle. Don't hesitate to visit with the office manager, head coach or current team families regarding the various options available for assistance with this account.
